TERMS FOR SENDING ANALYSIS REPORTS BY EMAIL

- Analysis reports are sent as a PDF file attached to an email.
- The email subject line will state: "Analysis report file No., order form reference, client, analysis, reception date".
- The attached PDF file will be named "File No. – client code – edition".
- If delivery fails and the report is not received, we will be automatically notified and will ensure the information reaches you as quickly as possible.
- **Data integrity** is guaranteed by an encrypted PDF file, which cannot be selected (copy/paste), modified, or saved. Only viewing and printing are permitted. The PDF file is a true copy of the paper report, which is kept by the laboratory for 5 years.
- **Message authenticity** is ensured by the sender's email address in the format @biochenevert.fr or @labofarm.com.
- **Confidentiality** is ensured by sending the analysis report only to the recipient's email address(es) listed above (or, if requested, to the email address provided on the analysis submission form). However, there is a risk of message interception. The laboratory cannot be held liable, as email security is generally comparable to that of postal mail.
- **Legal value**: The analysis report received as a PDF file by email, under the conditions described above and in accordance with the laboratory's general terms and conditions of sale or service, is legally binding.
- In the event of a dispute, the laboratory will make available to the client both the analysis report and the original analysis submission form.
